Subject: Notification on the acquisition of own shares
(Information on the acquisition and release of own shares (Art. 474 CMA))

Valamar Riviera d.d. with registered office in Poreč, Stancija Kaligari 1, PIN: 36201212847 (hereinafter: the Company), in accordance with Article 474 of the Capital Market Act and with the provisions of the Rules of the Zagreb Stock Exchange d.d. informs that on the basis of the Own Share Buyback Programme adopted on April 23, 2026, the investment company HITA-VRIJEDNOSNICE d.d., in the name and on behalf of the Company, made the following purchases of the Company's shares (own shares) on the regulated market of the Zagreb Stock Exchange d.d:

- on May 27, 2026, 1,500 shares at a price of EUR 7.70, 1,675 shares at a price of EUR 7.72, 2,500 shares at a price of EUR 7.74, 3,000 at a price of EUR 7.80, 4,000 at a price of EUR 7.82, so a total of 12,675 shares marked as RIVP, at an weighted average price of EUR 7.77, which represents 0.0101% of the Company's share capital;
- on May 28, 2026, 329 shares at a price of EUR 7.82, 1,214 shares at a price of EUR 7.88, 1,457 shares at a price of EUR 7.90, so a total of 3,000 shares marked as RIVP, at an weighted average price of EUR 7.88, which represents 0.0024% of the Company's share capital.

The Company consequently acquired a total of 15,675 shares and now holds a total of 3,439,135 of its own shares, which represents 2.7289% of the Company's share capital.
