Subject: Notification on the acquisition of own shares
(Information on the acquisition and release of own shares (Art. 474 CMA))

Valamar Riviera d.d. with registered office in Poreč, Stancija Kaligari 1, PIN: 36201212847 (hereinafter: the Company), in accordance with Article 474 of the Capital Market Act and with the provisions of the Rules of the Zagreb Stock Exchange d.d. informs that on the basis of the Own Share Buyback Programme adopted on April 23, 2026, the investment company HITA-VRIJEDNOSNICE d.d., in the name and on behalf of the Company, made the following purchases of the Company's shares (own shares) on the regulated market of the Zagreb Stock Exchange d.d.:

- on June 15, 2026, a total of 3,000 shares marked as RIVP at a price of EUR 8.60, at an weighted average price of EUR 8.60, which represents 0.0024% of the Company's share capital;
- on June 16, 2026, a total of 3,000 shares marked as RIVP at a price of EUR 8.70, at an weighted average price of EUR 8.70, which represents 0.0024% of the Company's share capital.

The Company consequently acquired a total of 6,000 shares and now holds a total of 3,475,135 of its own shares, which represents 2.7574% of the Company's share capital.
