Subject: Notification on the acquisition of own shares

Valamar Riviera d.d. with registered office in Poreč, Stancija Kaligari 1, PIN: 36201212847 (hereinafter: the Company), in accordance with Article 474 of the Capital Market Act and with the provisions of the Rules of the Zagreb Stock Exchange d.d. informs that on the basis of the Own Share Buyback Programme adopted on April 23, 2026, the investment company FIMA-VRIJEDNOSNICE d.o.o., in the name and on behalf of the Company, made the following purchases of the Company's shares (own shares) on the regulated market of the Zagreb Stock Exchange d.d:

- on July 2, 2026, 10 shares at a price of EUR 8.16, 990 shares at a price of EUR 8.22, 360 shares at a price of EUR 8.24, 2,140 shares at a price of EUR 8.28, so a total of 3,500 shares marked as RIVP, at an weighted average price of EUR 8.26, which represents 0.0028% of the Company's share capital;
- on July 3, 2026, 490 shares at a price of EUR 8.26, 2,117 shares at a price of EUR 8.28, 893 shares at a price of EUR 8.30, so a total of 3,500 shares marked as RIVP, at an weighted average price of EUR 8.28, which represents 0.0028% of the Company's share capital.

The Company consequently acquired a total of 7,000 shares and now holds a total of 3,523,401 of its own shares, which represents 2.7957% of the Company's share capital.
