The shares were acquired on 23 September 2021 at organized Stock exchange market Zagrebačka burza d.d., Zagreb.

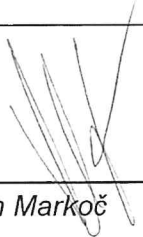
