Subject: Notification on the acquisition of own shares

Valamar Riviera d.d. with registered office in Poreč, Stancija Kaligari 1, PIN: 36201212847 (hereinafter: the Company), in accordance with Article 474 of the Capital Market Act and with the provisions of the Rules of the Zagreb Stock Exchange d.d. informs that on the basis of the Own Share Buy Back Programme adopted on June 18, 2025, the investment company Interkapital vrijednosni papiri d.o.o., in the name and on behalf of the Company, made the following purchases of the Company's shares (own shares) on the regulated market of the Zagreb Stock Exchange d.d.:

- on November 24, 2025, 298 shares at a price of EUR 6.46, 2,200 shares at a price of EUR 6.50, 1,056 shares at a price of EUR 6.52, 5,700 shares at a price of EUR 6.54, so a total of 9,254 shares marked as RIVP at an weighted average price of EUR 6.53, which represents 0.0073% of the Company's share capital;
- on November 25, 2025, 883 shares at a price of EUR 6.54, 5,617 shares at a price of EUR 6.56, 2,700 shares at a price of EUR 6.58, so a total of 9,200 shares marked as RIVP at an weighted average price of EUR 6.56, which represents 0.0073% of the Company's share capital.

The Company consequently acquired a total of 18,454 shares and now holds a total of 3,377,173 of its own shares, which represents 2.6797% of the Company's share capital.
