This notification is delivered because Mr. Davor Brenko is Senior Vice President for Sales and Marketing of the company Valamar Riviera d.d.

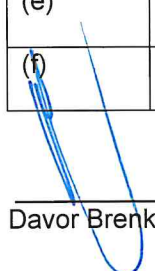
